He lectures, writes and consults world-wide in the fields of contract law, product liability and safety regulation, civil dispute resolution (especially arbitration), corporate governance, and cyber-law, mostly comparing developments in Japan or transnationally. Luke has published five books and over 100 chapters or major articles, mostly in English and Japanese, and contributes to three looseleaf commentaries. Luke serves on the Rules Committee of the Australian Centre for International Commercial Arbitration (ACICA), has lectured and written for the Chartered Institute of Arbitrators (CI Arb), and was a founding member of the Australasian Forum for International Arbitration (AFIA). Since 1990 Luke has worked closely with law firms and companies in New Zealand, Japan, Australia and the US in cross-border dispute resolution and transaction planning, and he is a founding Director of Japanese Law Links Pty Ltd.

Professor Richard Garnett (BA, LLB, *UNSW*; LLM, *Harv*) is a Professor at the Melbourne Law School, researching and teaching in private international law and international dispute resolution. He has published books and articles in leading international journals in these fields, a number of which have been cited by leading international tribunals such as the European Court of Human Rights and US federal courts. Professor Garnett has also acted as legal adviser and counsel in many matters before Australian and international tribunals and is currently a consultant to the law firm Freehills. Justice Clyde Croft (BEC/LLB/LLM, *Monash*; PhD, *Cambridge*) is a judge of the Commercial Court in the Victorian Supreme Court and also manages its commercial arbitration list, domestic and international. He was appointed Senior Counsel in 2000, having practised extensively in property and commercial law and was an arbitrator and mediator in property, construction and commercial disputes, domestically and internationally. He was an Institute of Arbitrators and Mediators (IAMA) Grade 1 Arbitrator (the highest grading), a member of the IAMA Australian and international panel of commercial arbitrators, a member of ACICA (serving on the Rules Committee from 2004-2009), the Singapore International Arbitration Centre (SIAC) and the Asia Pacific Regional Arbitration Group (APRAG) panels of international arbitrators. He represented APRAG at the United Nations Commission on International Trade Law (UNCITRAL) International Arbitration Working Group Sessions from 2005 until 2010.

Justice Croft is also a Life Fellow of IAMA and a Judicial Fellow of AMINZ. He was a Fellow of the CIArb and a member of the London Court of International Arbitration (LCIA). He was the IAMA National President (1997 - 2000) and was an IAMA National Councillor and IAMA Vice-President until his appointment. Justice Croft was the Treasurer, a Director and a Fellow of ACICA. He was an accredited mediator under the Australian National Mediator Accreditation System (and a Victorian Bar and IAMA Accredited Mediator) and a Sessional Member, Victorian Civil and Administrative Tribunal. He is the author, or co-author, of leading texts in the property, equity, leasing, securities and commercial law fields and of numerous articles and conference papers on commercial arbitration (domestic and international) and property and commercial law subjects. Justice Croft is an Adjunct Professor of Law, Deakin University, Melbourne.

Professor James Crawford SC, FBA, LL.D. is Director of the Lauterpacht Centre, University of Cambridge, Whewell Professor of International Law and a Fellow of Jesus College. He was a Member of the United Nations International Law Commission from 1992-2001 and Special Rapporteur on State Responsibility (1997-2001). In addition to scholarly work on statehood, self-determination, collective rights and international responsibility, he has appeared frequently before the International Court of Justice including in the Advisory Opinions on Nuclear Weapons (1996) and the Israeli Wall/Barrier (2004). He has also appeared before other international tribunals, and is

actively engaged as an international arbitrator. Before his appointment to Cambridge in 1992, he held Chairs in Law at Adelaide and Sydney, and was a member (1982-90) of the Australian Law Reform Commission. He is a member of the New South Wales and English bars, and was one of the founding members of Matrix Chambers, London (2000).

Jonathon DeBoos (BSc, Grad Dip Biotech, *Melb*; LLB (Hons), *Deakin*) is a lawyer in the International Arbitration Group and Construction & Major Projects Group of Clayton Utz. He is a Barrister and Solicitor of the High Court of Australia and the Supreme Courts of Victoria and New South Wales, specialising in international arbitration and international sales law. Christopher was a member of the ACICA Rules Committee from 2004-7 and (ad hoc) from 2010, and is a founding executive member and former Co-Chair of AFIA. He has published widely and is regularly invited to speak at conferences and deliver guest lectures.
